**Obutumwa Sande ya 3 om Maija, 14.12.2025 A
Mushemererwe, Mukama ari haihi kwija!
Isaaya 35:1-6a; Yakobo 5:7-10; Matayo 11:2-11**

Banyaruganda omuri Kristo, nimbaakiira aha Sande ya kashatu omu bwire bw'amaija kandi Sande yaitu y'okuhereruka omu mwka ogu ogwa 2025! Twaija hanuuya okusiima Mukama ahabwa byona ebi atukoreire. Mwebare kumanya ngu Mukama nimurungi! Mwebare kwebembeza obumwe bwaitu nk'eka ya AMDA! Manya turi bamwe omuri Kristo - obuzaare oburikutugaita hamwe nk'eka ya AMDA n'okugira akakwate na Kristo omw'itware ryaitu rya Mbarara! Paulo Entumwa nagaambira Abafilipi (4:13) kandi nagaambira iwe naanye ati: "nimbaasa byona naaba nkagatiire omuri Yesu." Ngu "omuri Yesu, nyine amaani g'okusingura!" Mwebare kukagatira omuri Yesu, nk'eka ya AMDA, mwebare kuba abasinguzi omumwaka ogu! Ebyo byona nitubisiimira Ruhanga obitubaasiise! Manya Paulo naagaruka atwijutsya ngu Ruhanga niwe atutamu okukunda ebi asiima n'okubikora (Abafilipi 2:13).

Missa yaitu n'okuhendera omwaka neehika omubwire bw'amaija turikwetebekekanisiza okuzaarwa kw'omujuni waitu Yesu Kristo. Abakundwa omuri Kristo, amaia ga Mukama gahika haihi! Okuruga aha Sande egi eya kashatu, twatsigaza wiiki emwe n'ekicweka tukakuza amazarwa g'Omujuni. Tutwire tutegyerize n'ekihika, okwesiga, n'amatsiko. Emitima yaitu etwiire



etegyereize Mukama nk'oku omurinzi ategyereza omushekye. Reeba nitwiririra n'okuhendera omwaka gwa 2025. Oine akasente akabikiire ebiro bikuru. Nangwa nabatari bakristo nabo emitima yabo netandika kutagata omubwire bwa Nohire. Manya okwija kwa Kristo nikureeta eneema n'okunanuka kw'emitima! Abashuubuzi n'abeby'engyenda nabo nibakimanya, batandika n'okwongyeza emihendo y'ebintu na transipoota n'obu ekyo kiraabe kitahikire. As we approach the dawn of the New Year, I invite you to join me in giving thanks to our faithful God for His continued provision, protection, and care throughout 2025. We are grateful for the fellowship we share, for walking together in unity, and for the growth we have experienced in line with our theme for the year: "Pilgrims of Hope."

Reflecting on 2025, we acknowledge that the year brought both joys and challenges, yet in all things, we thank God for His faithfulness in carrying us through.

2025 Highlights

Unity Pillar:

- Monthly prayers every last Sunday, small group meetings, and celebrations of weddings and anniversaries.
- Through the AMDA Bereavement Fund (ABF 1 with 800 members and ABF 2 with 282 members), we supported families in times of loss.
- We mourn the passing of Mrs. Teddy Ishungisa, Mr. Stanly Mulumba and his wife Deborah, and 34 members who lost loved ones. May their souls rest in eternal peace.

Spiritual Development:

We have prayed together as a family, with the parishes of Birunduma, Bihanga, Rwenkobwa, Ishongorero, Kenyena-Kyezimbire animating Mass. Also, PCJ - Philosophy Center Jinja, Education Council/Teachers, Holy Cross Lake View S.S.S, AMDA SACCO, AMDA

Whatsapp administrators animated Mass. This has contributed to our spiritual journey. We organized retreats, pilgrimages, and recollections, including the pilgrimage to Our Lady of Sorrows in Kibeho, Rwanda, and the MEPA pilgrimage to Namugongo. During the last caravan, 2000 medals and 1360 rosaries were distributed.

Economic Empowerment Pillar:

The AMDA SACCO Established in 2012, aims to promote thrift, savings, and financial stability among members.

In 2025, the SACCO achieved a membership of 965, a capital base of 3,326,000,000 UGX, and distributed dividends at a rate of 12.5% per annum. The SACCO has also provided affordable loans that enabled many members to start or expand small businesses, strengthening their economic growth.

In a historical share's growth campaign, the AMDA SACCO gave out a brand-new car to the winner of the raffle that was part of the campaign.

In the caravan to Nyamitanga and Kibona parish, we distributed 4,000 Robusta



coffee seedlings and 6,000 fruit seedlings, and trained women in various skills such as soap-making and baking. We also held talks on financial literacy and mindset change in Kibona and Nyamitanga alongside providing veterinary services and animal health programs.

Education Pillar:

In our caravan to Nyamitanga, we donated 100 textbooks for the new curriculum. We also supported the training of 100 secondary school teachers in the new curriculum.

The education council gave scholarships to 3 students from S.1 to S.6.

- Holy Cross SSS Jinja -Nyamitanga Parish S1 to S.6
- Standard High School Zana -Kiboona Parish S1 to S.6
- Timbitwire Girls School- Nyamitanga Parish S1 to S.6, (offered to Sisters of poor Clares)

Environmental Sustainability Pillar:

Through the Environmental Sustainability Council, we promoted environmental consciousness. We distributed 24,000 eucalyptus tree seedlings and conducted sensitizations on waste management, tree planting, and conservation agriculture.

The AMDA Caravan:



The 11th AMDA Caravan to Nyamitanga Parish was a great success, and we thank God for it! The AMDA Caravan is an annual outreach mission to select home parishes in Mbarara Archdiocese, where AMDA members originate. This year's caravan was particularly exciting as it attracted the highest number of specialized medical services, brought in new partners, and implemented several modified activities to enhance our impact. over 5,430 patients received vital medical care, including consultations, treatments, and health education. These also Included including 40 cataract surgeries, 40 cleft repairs, 14 hearing aids, and 413 reading glasses. We also screened 529

people for cancer, treated 359 at the dental clinic, and donated 231 pints of blood During the caravan, 260 AMDA members participated in various voluntary activities aimed at strengthening and empowering the Catholic communities of Nyamitanga and Kibona parishes. These activities centered on our seven AMDA pillars: Unity, Spiritual Development, Leadership Development, Economic Empowerment, Education, Health and Wellness and Environmental Sustainability.

AMDA Rubaga Construction Project



I heartily thank the animating parishes and groups throughout the year 2025 who were able to raise funds towards construction of the Multipurpose Hall and a Clergy residence at Rubaga. With these resources, we have been able handover the two floors of the clergy residence tiled, painted and habitable. During the Tutaahé Rubaga event held on 24th November, 2024, mobilize UGX 762 Million in both cash and pledges though most of the pledges remain unfulfilled and encourage members remain unfulfilled.

Let us embrace this opportunity with joy and commitment, knowing that our participation strengthens AMDA today and secures its future for generations to come.

3.Leadership Prayers:

Walking Together in Faith: The Work of the AMDA Spiritual Council in 2025

The year 2025 was marked by spiritual growth, renewal, and strengthened fellowship within AMDA

and for the AMDA Spiritual Council. Guided by its mission to nurture the spiritual growth of members and deepen their relationship with God, the Council led AMDA through moments of reflection, renewal, celebration, and remembrance. Through monthly Masses, recollections, pilgrimages, the annual Caravan, counselling sessions, and devotional gatherings, members were continually invited to grow in faith and hope.

Throughout the year, the Council worked closely with chaplains, clergy, facilitators and fellow councils to ensure that spiritual activities were well organised, meaningful and accessible to members across parishes.

Anchoring AMDA in Prayer: Monthly Masses



The Spiritual Council remained actively involved in the AMDA monthly Masses held on the last Sunday of each month. Members served as ushers, animated the liturgy and supported the children's ministry, creating a welcoming and prayerful atmosphere. These regular gatherings strengthened unity, encouraged reflection on personal spiritual journeys and reaffirmed AMDA's commitment

to a faith-centred life.

The introduction of an overseer greatly improved coordination, ensuring that Masses and other spiritual activities were conducted smoothly and with reverence.

Lenten and Advent Recollections

The Council organised two major recollections to help members prepare spiritually for key moments in the Church calendar.

The Lenten Recollection was held on 9 March 2025 at AMDA Rubaga House under the theme "Come back to the Lord with all your heart" (Joel 2:12). Facilitated by Rev. Fr. Kamukama Leonard, the recollection brought together about 150 participants from different parishes. Members were guided to reflect on repentance, the sources of spiritual challenges and the importance of fasting and prayer as taught in Scripture. The day included a penitential service, adoration of the Blessed Sacrament and the celebration of Mass, allowing participants to experience God's mercy and renewal.

Later in the year, the Advent Recollection was held on 7 December 2025 at Rubaga House and was facilitated by Rev. Fr. Blaise Ndyabangira. This recollection prepared members for the joyful celebration of Christ's birth through moments of prayer, reflection and spiritual renewal as the Advent season began.

Pilgrimages: Journeys of Hope and Renewal



Pilgrimage was a central theme of the Spiritual Council's work in 2025, guided by the theme "Pilgrims of Hope."

The annual pilgrimage to Kibeho took place from 9 to 11 May 2025. The Council actively animated the pilgrimage through prayer on the buses, singing, the Way of the Cross, the Way of the Rosary, the Seven Sorrows Rosary and family prayers at Cana. Participants received deep teachings on hope and healing, with many sharing testimonies on the return journey about God's healing and deliverance. While the pilgrimage was spiritually enriching, challenges such as delayed travel led to the cancellation of the Friday Mass. The Council recommends earlier departures and closer collaboration with the Leisure and Events Council for future pilgrimages.

On 9 June 2025, the Council organised a Jubilee Year Pilgrimage to Munyonyo Martyrs Basilica, facilitated by Rev. Fr. Anthony Ezenekwe from Namugongo. About 200 participants from the MEPA community attended. The day included a guided tour of the shrine, entry through the Door of Hope, a powerful teaching session on hope, adoration of the Blessed Sacrament and the celebration of Mass. Due to time constraints, the programme was half-day, and members expressed a strong desire for 9 June to be marked annually on the AMDA calendar in honour of the Uganda Martyrs.

In addition, a number of AMDA members participated in an international pilgrimage to the Holy Land and Europe. This spiritually rich journey included



visits to Fatima, Santiago de Compostela, Lourdes, Paris, Rome, Lanciaio, San Giovanni Rotondo and Assisi. Members celebrated Mass, prayed at holy sites, passed through the Holy Door at Santa Maria Maggiore Basilica and experienced the unity of the universal Church, including an opportunity to meet the Pope. The pilgrimage offered deep spiritual renewal and inspiration.

The AMDA Caravan: Faith on the Move

The AMDA Caravan to Nyamitanga, held from 28 to 31 August 2025, was a major spiritual highlight of the year. The Caravan was preceded by a nine-day novena, which members actively participated in.

The opening Mass at Christ the King Parish was presided over by Rev. Fr. Prosper Atukwatse and Rev. Fr. John Baptist Nsubuga. Throughout the journey, spiritual animators led prayers on the buses, and hymn and prayer books were distributed to participants. Plenary sessions on the theme of hope were delivered in Kibona and Nyamitanga by Rev. Fr. Darius Magunda and Rev. Fr. Prosper Atukwatse.

The Council also supported the children's ministry by donating rosaries, medals,

portraits and an altar cross. Counselling sessions were conducted in Kibona, while additional counselling and the Sacrament of Penance were offered on Saturday by the St. Francis Counsellors Institute alongside 20 priests. Saturday Mass at Maryhill High School chapel was celebrated by Rev. Fr. Gaston Muhwezi, and the Caravan concluded with a High Mass presided over by His Grace, Archbishop Lambert Bainomugisha.

Challenges included low attendance at the opening Mass and limited prayer reverence on one of the buses. The Council recommends consistent announcements and the sharing of digital and printed prayer reminders to strengthen participation and focus.

Remembering Our Loved Ones: All Souls Day Mass

On 3 November 2025, AMDA held its annual All Souls Day Mass at Christ the King Parish, presided over by Rev. Fr. Isingoma Adolf. His homily on the Body, Soul and Spirit offered comfort and hope, reminding members of the Christian call to holiness and eternal life. A candle-lighting ceremony allowed members to honour departed loved ones, creating a deeply moving

moment of shared remembrance and communal support.

Devotion and Fellowship: Joint Rosary Recitations

The Spiritual Council organised joint rosary recitations online during the months of May and October. In May, the rosary was animated by various AMDA WhatsApp stations, while in October it was led by AMDA families, councils and Small Christian Communities. These shared moments of devotion strengthened unity and deepened the prayer life of members across distances.

Intercession Prayers

As part of strengthening AMDA's prayer life, the Council plans to introduce monthly intercession prayers to be held every Tuesday of the second week of each month. These sessions will focus on praying for AMDA's mission, activities and intentions. The first session is scheduled for 9 December 2025, marking the beginning of a structured commitment to collective intercession.

The Spiritual Council remains committed to fostering a vibrant prayer life and encouraging deeper faith engagement among members in 2026.

The Council extends heartfelt appreciation to the AMDA Executive Committee, chaplains, clergy, catechists, choir and praise team, facilitators, donors and all AMDA members for their support. Special thanks go to Holy Cross Ministries and Lake View Holy Cross S.S for their outstanding contribution to AMDA's spiritual programmes and the Caravan. The Council also gratefully acknowledges Eng. Anthony Rucukye for his insightful teachings on the Catholic faith and his dedicated guidance during quizzes across AMDA WhatsApp stations.

As we move forward, the Spiritual Council looks ahead with hope, trusting that continued prayer and fellowship will guide the Association in faith and service

Overall, the association maintained a stable financial position, with improved cash flows driven by end of month Mass collections, individual contributions, and donations. However, delayed pledge disbursements continue to affect liquidity.

Loan repayment is up to date as of November 2025; however, the income flows have been on average below the target of 10 million per month as earlier anticipated. Donations/contributions were below budget—major donor disbursement expected from the Chief Guest on Tutaahe Rubaga Project is still pending, efforts are needed to persuade him. Details are attached.

Project Funding:
The funding of this project solely depends on funds collected voluntarily from AMDA members, friends, acquaintance and well-wishers. Whenever an opportunity arises, we

appeal to any individual or organisation, Associations, parishes, etc willing to extend a hand towards realisation of this project. The support and contribution have been in form of money and/or construction materials. The mode of implementation of the project is that we contract out labour and buy materials ourselves through the treasurer and our construction committee supervisors. The construction committee is currently headed by Eng. Anthony Rucukye. For security, safety and record keeping of our materials and the building, exco made a decision and employed casual labour in the names of Clinton Kujuna at UGX.20,000 per day and has been handy in ensuring the place and our materials are secure.

Introduction

AMDA BEREAVEMENT FAMILY (ABF) LTD is an association whose membership is comprised of AMDA members whose objective is the pooling together of capital and or resources with the aim of using the same to help the members have a befitting send off for themselves and their immediate relatives and to enhance the unity of AMDA.

The operations of AMDA BEREAVEMENT FAMILY (ABF) are overseen by a Management Committee comprised of dedicated members and supported by AMDA Bereavement Family (ABF) Ltd administrator Mr. Nuwamanya Gerald.

Membership

AMDA Bereavement Fund/Family -Tier One (ABF1) started its

operations on 1st July 2016, while ABF Tier Two (ABF2) started its operations on 1st May 2024 with the primary objective of helping its members and their loved ones in case of death.

The fund management implemented AGM resolution of capping membership of ABF1 to 800 members and create ABF Tier-2 whose membership has raised and currently stands at 282 members. All intending members that want to join ABF are encouraged to join ABF Tier two and joining guidelines are available with management or administrator.

During the year we lost 7 immediate relatives for the members of ABF-2 and lost 34 immediate relatives for the members of ABF-1 and 1 ABF 1 member.

FAQS

AMDA BEREAVEMENT FAMILY (ABF) LTD -FREQUENTLY ASKED QUESTIONS (FAQS)

(Please note that, where amounts have been stated, such amounts are indicative of the status quo, but may be revised from time to time as agreed upon by the AMDA Bereavement Family (ABF) Tier - Two members).

Q1: What is AMDA Bereavement Family Tier Two (ABF 2) and when did it start?

A1: ABF 2 stands for "AMDA Bereavement Family Tier Two" and it commenced on May 01, 2024.

Q2: How much is needed to join the ABF 2?

A2: Membership is currently at **UGX 50,000** while the monthly subscription is currently at **UGX 20,000.**

Q3: Regarding monthly contributions, can someone pay a lumpsum?

A3: Yes and it is highly encouraged. Some ABF 2 members have paid an annual lumpsum (20,000x12=240,000 at once).

Q4: What are the monetary entitlements to ABF 2 members in case of a death event occurring?

A4: When a member dies, his/her family (the next-of-kin) currently receives UGX 1,000,000. If a member loses a qualifying relative/beneficiary (as highlighted in Qn5 below), s/he currently receives UGX 500,000.

Q5: Who is a "qualifying relation" referred to in Qn4 above?

A5: A member's relatives.

- Biological/legally adopted children
- Father/guardian
- Mother/guardian
- Spouse

-Siblings, but only for the clergy and religious.

Q6: Are there any other monetary benefits a bereaved member/family gets?

A6: Yes, apart from UGX 1,000,000 and UGX 500,000 payable in the events described above respectively, each ABF member is currently constitutionally required to contribute a minimum UGX 10,000 to the bereaved member/family.

Q7: If I joined today (now), would I be required to pay an amount of money to be at par with members that commenced with the fund on May 01, 2024?

A7: Yes. All those members who join from time to time are required to pay monies that must bring them at par with members that joined on May 01, 2024 when the ABF 2 commenced. Because we are already investing the money contributed by existing ABF 2 members, this is also to make sure that new entrants are entitled to the same benefits like those of existing members.

Q8: What are the obligations of ABF 2 members?

A8: Identifying with other members in times of need e.g. attending any sanctioned meetings, and in case of death attending the vigil, requiem Mass, burial, etc.

Q9: Can a couple or family or group join the ABF 2 as "one member"?

A9: No, each member joins the ABF 2 in their own individual right/capacity.

Q10: In relation to Qn. 4 & Qn. 9 above, what if say 03 people who are brothers and or sisters lose their biological parent/guardian say a father/mother, does their family receive the contribution 3 times?

A10: Yes. Each member is looked at in their own individual right/capacity and in this case, each of these 3 members will have lost a father thus their

membership positions receiving UGX 1,500,000 (each member receiving UGX 500,000).

Q11: Can I have multiple membership positions in ABF 2?

A11: No, each person must have only one membership position in ABF 2.

Q12: Must a member be a natural person or an organization can become an ABF 2 member?

A12: A member of ABF 2 must be a natural person.

Q13: Who qualifies to be a member of ABF 2?

A13: Any AMDA member qualifies to be a member of ABF 2.

Q14: Are there penalties for members that do not comply with ABF 2 rules and regulations?

A14 (a): A member who misses a scheduled meeting without clear justification shall be required to pay a fine of UGX 10,000.

A14 (b): A member whose position of arrears is more than 2 months (an equivalent of UGX 40,000) shall not be entitled to benefits in Qn. 4 and Qn. 6 above when s/he loses a relative. The same penalty shall apply to his/her family when s/he passes on.

A14 (c): A member whose is in arrears of UGX 240,000 and above, at least 2 months before his/her death or death of his/her loved ones/beneficiaries shall forfeit all her/his benefits to the fund UPON his/her death or death of his/her loved ones/beneficiaries.

Q15: The Fund may accumulate lots of money than is needed to cover member entitlements relating to deaths - what happens?

A15: ABF 2 members shall determine from time to time how to invest such excess funds so as to earn a return on their investment.

Q16: I want to join the ABF 2 today, who do I pay the money to?

A16: You deposit the money on the AMDA Bereavement Family (ABF) Ltd Bank Account Number 3100108904 held in Centenary Bank, Mapeera Branch.

Q17: Is entry into ABF 2 immediate and automatic or not?

A17 (a): Entry isn't immediate and automatic. Any person intending to join ABF 2 must have his/her application vetted for a period of not less than 2 calendar months before being considered a member of the Fund.

A17 (b): Also, any person intending to join ABF 2 must have his/her application endorsed by both his/her Catholic Parish Coordinator and AMDA Executive Committee.

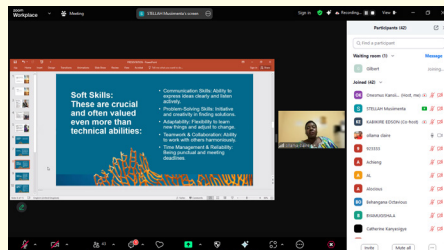
AMDA Youth 2025 Report

AMDA Youth Handover And Youth Day Out: A Celebration Of Leadership And Community



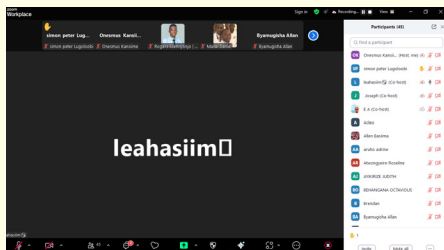

Tips on balancing sports engagements and other holiday activities

As we commence the holidays and the festive season, I wish to borrow from Margot Starbuck and David King works to highlight a few tips to enable our children balance sports and other activities:

Sports schedules should not trump all other commitments. When our children play on a team, we expect them to show up to practices and games. This in principle teaches them a lesson on commitment. However, what happens when there is a conflict with another important family activity?

The day the coach hands out the schedule, review it as a family and let the coach know which practices or games your child will miss because of other commitments. Help your child understand that how they spend their time reflects their values. And whenever they have competing commitments, relationships trump sports.

Consider your family's needs and priorities: Choices regarding the amount and level of a child's participation in organized sports can have both positive and negative consequences. Participation in sports requires time, practice, travel, and money to fund the activity. Hours spent running here and there for practices and games, as well as the additional amount of time required for travel leagues, can crowd out other priorities. Key questions to ask:

Does participation in sports keep your child from church, youth group, or taking time to worship with other church members?

Do sports prevent your family from spending quality time together?

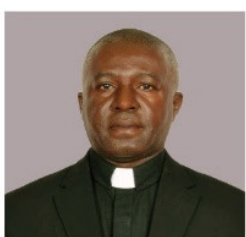

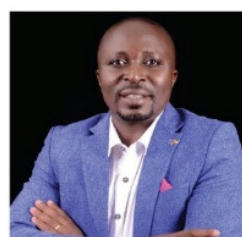

AMDA Leisure and Events Council: Serving with Order, Care, and Commitment in 2025

Throughout 2025, the AMDA Leisure and Events Council quietly but diligently worked behind the scenes to ensure that AMDA activities were well planned, smoothly executed and memorable for all involved. Headed by Mr. Maurice Behakanira, the Council played a central role in coordinating logistics, managing service providers and supporting the Executive Committee and other councils to deliver successful events.

From early planning visits to large-scale pilgrimages and the annual Caravan, the Council's work focused on one goal: making sure AMDA members could serve, pray and fellowship in an organised and welcoming environment.

Preparing the Ground: Caravan Pre-Visit to Nyamitanga

The Council's year began with a critical assignment — organising and participating in the Caravan Pre-Visit to Nyamitanga Cathedral, Kibona Parish and

Katukuru Parish. Conducted on Saturday, 8 February 2025, the visit was aimed at assessing the readiness of the parishes to host the AMDA Caravan.

The Council organised transport and accommodation for the team, carried out needs assessments and administered a readiness questionnaire across the three parishes. The findings were compiled into a comprehensive report that was submitted to the AMDA Executive Committee. This report played a key role in guiding decision-making and ultimately led to the selection of two parishes that met the required standards.

From this experience, the Council recommends that future pre-Caravan visits be conducted earlier in the year, preferably in January, to allow more time for engagement and mobilisation with hosting parishes.

Setting the Pace: The AMDA Caravan Launch

On 3 April 2025, the Leisure and Events Council successfully

organised the AMDA Caravan Launch at Hotel Africana. The Council secured the venue, coordinated catering and ushering services, and advised the Executive Committee on guest numbers to ensure smooth seating and flow of the programme.

Planning meetings were held in advance, allowing the launch to proceed in an orderly and dignified manner. Looking ahead, the Council recommends that hosting parishes submit their guest lists early to support proper seating arrangements and enable the Master of Ceremonies to appropriately recognise invited guests.

Walking Together in Faith: Pilgrimage to Kibeho

Nurturing Faith, Confidence and Leadership: **The AMDA Children and Teens Ministry in 2025**

The year 2025 was a vibrant and transformative journey for the AMDA Children and Teens Council. Throughout the year, children and teenagers actively participated in spiritual, social, leadership and community-based activities that strengthened their faith and built their confidence. Key highlights included participation in the AMDA Caravan, MEPA, and the pilgrimage to Namugongo, experiences that left a lasting impact on many young members, some of whom were attending such events for the very first time. Guided by its commitment to nurture children and teenagers in faith, responsibility and leadership, the Council continued to promote meaningful participation of young people in both church life and community development.

Growing Together: Membership and Leadership
In 2025, the Council brought

together a lively and committed group of young members. Over 87 children aged 6 to 13 years and more than 100 teenagers aged 14 to 18 years participated actively in Council activities. This strong membership reflects the growing trust of parents and parishes in AMDA's child-centred programmes.

The Council was led by a dedicated leadership team supported by committed Sunday school teachers who played a key mentoring role. The leadership include Mrs. Caroline Kagwire as Chairperson, Mrs. Prudence Muhwezi as Vice Chairperson, Mr. Edgar Nuwajuna as Secretary, and Mr. Amany Justus as Treasurer. They were supported by a team of Sunday school teachers whose guidance helped nurture discipline, confidence and faith among the children and teens.

Building Faith at the Centre
Spiritual formation remained the foundation of the Council's work. Throughout the year, children and teens actively participated in Mass, rosary

prayers and catechism sessions, especially during AMDA monthly Masses and MEPA gatherings. Sunday school sessions provided structured learning on Catholic doctrine, sacraments and values, while children also learned traditional Catholic prayers and developed a strong devotion to the rosary.

During major gatherings such as the pilgrimage to Namugongo, children and teens confidently led prayer sessions and scripture readings, demonstrating growing spiritual maturity and a strong sense of belonging to the Church.

The AMDA Caravan: A Defining Moment

The AMDA Caravan was the most impactful activity of the year for the Children and Teens Council. Children and teenagers from Nyamitanga and Kiboona parishes participated fully in faith-based sessions, peer learning discussions and social activities.

Through games, music, dance, drama and prayer, the children

expressed themselves creatively while addressing important issues such as child neglect, peer pressure, the value of education and the importance of discipline. Riddles, songs and short skits became powerful tools for learning and reflection.

A particularly inspiring moment was seeing children confidently speak before public gatherings on children's rights and responsibilities, the importance of prayer and obedience, and the role of children in the Church. These moments reflected the Council's success in building leadership and advocacy skills among its members.

Learning From One Another

Beyond major events, the Council encouraged continuous social interaction and peer learning. Exchange sessions between children from Nyamitanga and Kiboona parishes allowed them to share experiences about school, family life and community challenges. Group discussions, games and music strengthened unity and teamwork while helping children develop communication and social skills.

Creativity also played a central role throughout the year. Children showcased their talents through cultural performances, liturgical dances, poetry, drama and public speaking. These activities not only entertained but also taught valuable lessons in discipline, teamwork and faith.

Achievements to Celebrate

In 2025, 67 children participated in activities in Nyamitanga, while 112 took part in Kiboona during the Caravan. The Council also successfully supported children's participation in the pilgrimage to Namugongo and MEPA at the shrine. Monthly Sunday school sessions at Rubaga strengthened faith formation, while friendships

and networks grew across the two parishes.

Children and teens demonstrated improved understanding of Catholic teachings, prayers and rosary devotion, alongside growing confidence in leadership and public speaking. Many children proudly participated in their very first Caravan, marking an important milestone in their faith journey.

Challenges and Lessons Learned

Despite the successes, the Council faced several challenges. Limited time during Caravan parish visits affected deeper engagement, while shortages of child-friendly learning materials, seating space and refreshments posed difficulties. Transport delays and the lack of printed catechism and prayer materials also affected some activities.

From these experiences, the Council learned that children thrive when entrusted with responsibility, that peer-to-peer learning is highly motivating, and that combining faith teachings with community development themes enriches learning. Exposure to other parishes was especially effective in building confidence and broadening

children's perspectives.

Building on the gains of 2025, the Children and Teens Council plans to expand its programmes in 2026. Planned activities include holiday engagement sessions for teenagers, the introduction of a Monthly Rosary and Bible Reflection Day, and the production of simple prayer booklets for children.

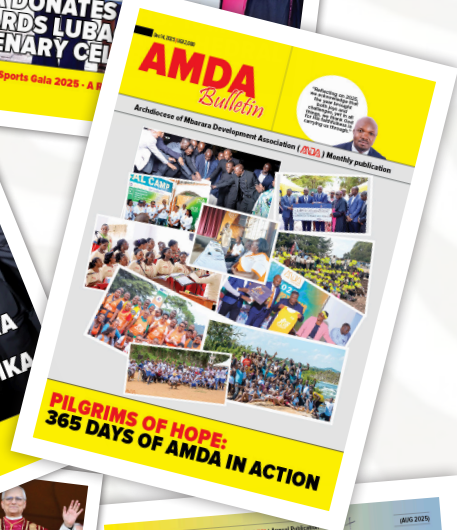
The Council also aims to strengthen leadership through youth boot camps, mentorship programmes and training in communication and public speaking. Community outreach activities such as clean-up campaigns, visiting the elderly and charity drives are planned, alongside greater involvement of children in parish development initiatives.

Administrative improvements will focus on better record-keeping, documentation, and advocacy for increased budgets for child-centred activities. Early preparation and improved coordination will also guide participation in the 2026 AMDA Caravan.

The year 2025 was truly a season of growth, blessing and transformation for the AMDA Children and Teens Council. Through faith-centred activities, leadership development and community engagement, children and teenagers grew spiritually, socially and emotionally.

With continued support from AMDA, parish leaders, parents and the wider community, the Council looks forward to an even more impactful year ahead. May the spirit of “Let the children come to God” continue to guide all programmes and actions in 2026 and beyond.
